Notice is hereby given that a meeting of the elecors of the Nadleh Whut'en band will be held at the Nadleh Whut'enne Yah Gym, located at 823 Nautley Road on Tuesday the 20th day of February, 2024 beginning at 5 (five) p.m. and lasting for at least three hours, for the purpose of nominating candidates for the position of one (1) chief and five (5) councillors for the Band Council of the said Band for the next ensuring term.

The **election** will be held at the **Nadleh Whut'enne Yah Gym**, located at **823 Nautley Road** on **Tuesday, April 2, 2024** with the polls open from 9 a.m. to 8 p.m. Also note that any voter may vote by mail in ballot.

Mail in ballots will be sent to every off-reserve member for whom the band has an address. Any member who would like to use the mail in ballots may do so by contacting the Electoral Officer and requesting a ballot be sent.

Please note that any voter may nominate candidates by using a mail-in nomination form. You can either deliver, mail-in or e-mail a written nomination form and a **completed, signed and witnessed** voter declaration form to the Electoral Officer before the time set for the nomination meeting OR you may nominate candidates at the nomination meeting. Mailed nominations not received by the Electoral Officer before the time set for nominations meeting are void.

RELEASE TO FIRST NATIONS

NADLEH WHUT'EN INDIAN BAND

NADLEH WHUT'EN CONTINUES SEARCH PROCESS AT THE FORMER LEJAC INDIAN RESIDENTIAL SCHOOL

Due to the confirmation of unmarked burials throughout BC and Canada, Nadleh Whut'en requests the utmost honour and respect for the grounds of the former Lejac Indian Residential School.

Nadleh Whut'en Indian Band, BC (December 2023) – Nadleh Whut'en continues the implementation of search processes around children who did not return home from the federally administered, Roman Catholic Church operated, Lejac Indian Residential School, under a project entitled *Whuz Noolh'en* or "we are looking / searching" in an area known to its people as Tseyaz Bunk'ut.

The geophysical survey methods of ground penetrating radar and magnetometry have been completed on a small area of the former Lejac Indian Residential School grounds. Results from the geophysical findings will be made in the new year allowing ample time for professional analysis.

Geophysical survey methodologies are but one aspect of the entire process and must be executed conscientiously, meticulously and in a trauma informed manner. Nadleh Whut'en will move forward in a manner respectful of Survivors of the Lejac Indian Residential School, First Nation governments and with the support from provincial and federal governments.

The findings of unmarked burials on or near former Indian Residential Schools from the Tk'emlúps te Secwé pemc, the T'exelcemc of the Williams Lake First Nation and the S'ólh Téméxw (Stó:lō), elevate awareness for healing and supports for Indian Residential School Survivors and the legacy of intergenerational trauma. Nadleh Whut'en is one of many First Nations in Canada tasked with stewarding IRS investigative processes in their territories and understands the work must be implemented with appropriate capacity and supports.

In 2022, Nadleh Whut'en was represented as part of the Indigenous delegation meeting Pope Francis at the Vatican and to Maskwacis as witness to #58 of the Truth and Reconciliation's Calls to Action where the Pontiff extended an apology for the Roman Catholic Church's role in genocidal practices committed at Indian Residential Schools in Canada.

Thank you for contacting Klein Lawyers LLP and expressing interest in the Indian Hospitals class action.

On June 13, 2018 we filed our case against the Government of Canada on behalf of Indigenous persons who suffered harms as a result of being placed in Indian Hospitals. We are pleased to report that on January 17, 2020, the Honourable Justice Favel certified the Federal Court lawsuit as a class action. The Government of Canada consented to the certification, so no appeal will be filed. A copy of the Certification Order is on our website. Having the case certified as a class action is a significant step in moving the case forward, but please keep in mind that certification does not mean that this case has settled.

A class action is a lawsuit that groups people with a common claim together against the same defendants. Class actions allow people whose voices might otherwise go unheard to fight together for a common interest. This process makes it possible for people, by joining together, to challenge even the largest organizations.

As you are interested in this case, we have added you to our mailing list. Although we do not represent you in this matter, we will do our best to inform you once this action settles. 

(Stellaquo Village/Nadleh Village/Fraser Lake, BC) Stellat'en First Nation and Nadleh Whut'en chiefs and councils are expressing deep sympathy to those who have lost their jobs due to the sudden closure of the Fraser Lake Sawmill. The sawmill is the economic engine of Fraser Lake, the villages of Stellaguo and Nadleh, and the surrounding region. After years of work by the nations and the province to protect the forest industry in this region, West Fraser unilaterally shut the mill with no regard for those affected.

"We've got members who work at that sawmill, and so does Nadleh," said Chief Robert Michelle of Stellat'en First Nation. "Add to that the job losses from people working in the bush, hauling logs, all the way down

to people working in restaurants and pumping gas, and you can see the economic impact for our communities will be dire."


It has been well-known that the Fraser Lake sawmill, like many other mills, in the region have had challenges accessing economical fibre due to high rates of salvage harvest following the disastrous mountain pine beetle infestation over the last 25 years. Reduced international demand for dimensional lumber further impacts this already difficult situation. Nadleh and Stellat'en have been working with the Province in recent years to attempt to secure fibre for the mill; West Fraser's decision to close the Fraser Lake Sawmill came despite this continued effort on behalf of governments.


"We have been trying to make a difference in the forest industry, to ensure that we all have a future with this industry, and with one announcement, West Fraser ruined it," said Chief Martin Louie of Nadleh Whut'en. "If West Fraser is not interested in supporting the regional economy, then we need to ensure that the forest resources that they continue to control -- the licenses themselves -- are transferred to local interests," he continued. "Working collectively with industry and government,

our Indigenous communities have ensured economic impacts from LNG benefit Northern BC. Innovative solutions to local forest industry problems will follow this positive trend."

Stellat'en and Nadleh are calling on the province of British Columbia to extend further resources to their nations and the people of Fraser Lake to provide training to work in other sectors, temporary increases in funding to the municipality of Fraser Lake to maintain adequate levels of services, and investment in the local economy from small business development through to large-scale industrial projects.

"We stand shoulder to shoulder with our non-Indigenous neighbours as we all endure these lean times together," said Chief Michell. "We know our territories can and will provide wealth for our nations and our neighbours in the future. Right now we all need support from our fellow British Columbians to diversify our economies across the north."
