## Nadleh Whut'en Indian Band Post-Secondary Student Support Program

### FUNDING CONTRACT

This contract between the Nadleh Whut'en Band and the undersigned student for the purpose of acquiring educational assistance from the Nadleh Whut'en Band in order to pursue a post-secondary program of studies.

I have read the Nadleh Whut'en Band's Post-Secondary Education Policy. I understand its contents and intent and therefore I agree that:

1. I will complete and sign the Nadleh Whut'en Band Educational Sponsorship Application Form and return it to the Nadleh Whut'en Band.
2. Once my application has been approved, the Band will notify the post-secondary institution by sending a Letter of Sponsorship or Support.
3. I understand that my application will be reviewed with the criteria within the Policy being taken into consideration.
4. Tuition will be paid to the Educational Institution. Book and Living Allowances (for students who qualify as Full-time Students) will be paid directly to the student. Living allowances will be paid directly to the student, preferably as a direct deposit into the student's bank account on the 25<sup>th</sup> of each month for the following month (if the 25<sup>th</sup> falls on a weekend or holiday it will be deposited on the Friday before).
5. Should I not complete the Course or Program of Studies that I have entered into for reasons other than medical release, I will pay any monies that the Nadleh Whut'en Band has paid toward my education from the dates mentioned in this agreement.
6. Should I withdraw or be terminated by the institution I will pay the Nadleh Whut'en Band the money owed to within one calendar year from the date of withdrawal or termination of studies.
7. Until all transcripts of sponsored courses have been provided to the Education Coordinator and all outstanding debts are paid to the Nadleh Whut'en Band, I understand that I will not be eligible for further funding.

Once I have received my allocation for Living Allowance and Book Allowance, I will be responsible for my own actions and will be expected by the Nadleh Whut'en Band to spend this money accordingly. I understand it is the policy of the Nadleh Whut'en band not to give advances for Book or Living Allowance.
